### **Using the WhatsApp communications app**

In order to exchange important information with the participants of the youth conference, we would like to use a WhatsApp group.

WhatsApp is a communications app that accesses contacts in the telephone book and forwards them to unknown servers. We would like to draw your attention to this fact, which is critical from a data protection perspective.

Nevertheless, we have decided to communicate via WhatsApp because most young people can be reached quickly and reliably in this way. We assure you that we will handle the participants' data with confidence and will not exchange confidential content via this platform.

### **Insurance and liability**

The City of Regensburg insures against accidents (disability and death) and third-party liability. An existing private accident and personal liability insurance is subject to advance payment.

The City of Regensburg does not assume liability for lost items belonging to the participants. It is also not liable for damage caused by participants through negligence or gross intent.

### **Duty of supervision and availability**

During each event, the Office for Municipal Youth Work, or its representatives, will assume the duty of supervision at the previously determined and communicated times.

Parents or legal guardians or their representatives must be reachable by telephone during the youth conference (telephone number under item 1. Personal information).

**Exclusion from the event**

In the event that a participant during a youth conference continuously disobeys the instructions of the supervisors, violates applicable law (drug use, theft, etc.), is unable to fit into the group or significantly disturbs or endangers the community or the course of the conference, the Office for Community Youth Work is entitled to exclude him/her from the event.

**Corona protective measures**

It is expected that the youth conference will take place under the 2G regulation, i.e. proof of vaccination recognised in the EU or proof of recovery must be presented. Please note the requirements for proof of vaccination or recovery valid in Germany at the time of the conference.
